LDAC 2019 — Submitted by Kelly Yeatts, MAI

We had a very successful LDAC 2019 for VCCAI. Three representatives from the chapter attended: Kelly Yeatts, MAI (Third Year), Amy Edmonds, MAI (Second Year), and Lynn Kelsey, MAI (First Year). Discussion topics this year included alternative residential products, educational opportunities in the profession, effective client messaging, and increasing the value of chapters to members. The discussion groups, as always, were lively and resulted in many thoughtful suggestions and efforts. The discussion leaders guided conversations effectively, finding commonalities among various groups to determine several recommendations and conclusions.

Congressional lobbying took place on May 16th and the Virginia delegation had an extremely successful showing. VCCAI collaborated with our counterparts from the Hampton Roads chapter to lobby our Senators and Representatives. Both Senators' staffs met with our members, as did three other Representatives. Our VCCAI representatives were also honored to speak directly with Congressman Morgan Griffith (VA-9) during the lobbying sessions. Lobbying topics this year included regulatory modernization for the profession – including national databasing for licensing, etc. – as well as discussions on the topic of threshold increases. While there was no active legislation to push during the visits, our meetings resulted in good contacts with our national representation to become sources of information regarding the profession.

During the closing session, the membership was surprised by a visit from Ted Anglyn, MAI, an esteemed colleague and the man responsible for going to the national board to save LDAC in the early 1990's. His impact on LDAC remains today, as the Ted Anglyn Award is given to the top first year participant each year. This year, the award was earned by Kathleen Hendersen, a Practicing Affiliate from Oregon. Many thanks are due to Chair Steve Henry, MAI, Vice-Chair Jacinto Munoz, MAI, SRA, AI-GRS, AI-RRS, and Discussion Leaders Erik Hanson, MAI; Lisa Meinczinger, SRA, AI-RRS; Robert Moorman, MAI, SRA, AI-GRS; and Eric Schneider, MAI, SRA, AI-GRS, and President-Elect Jefferson Sherman, MAI, AI-GRS, of the national organization. The chapter wishes next year's leadership team, including Kelly Yeatts, MAI, who has been selected as a Discussion Leader, the best of luck in their endeavors to make LDAC 2020 a wonderful experience for all participants.


