 - a. Attended two of the applicant's Chapter meetings prior to receiving a 2022 VCCAI scholarship award;
 - b. Attended a Chapter or Region Candidate Guidance meeting;
 - c. Recommendation for a VCCAI Scholarship by a Designated Member (attach recommendation).
- 4) Applicant must submit a completed application to the VCCAI Scholarship Committee Chair (this form).
- 5) Applicant must submit a few paragraphs stating why he or she should be awarded the scholarship highlighting professional goals and experience.
- 6) Applicant must submit a resume or statement of qualifications.
- 7) Applicant must submit a list of completed Appraisal Institute courses and designation requirements to date.
- 8) *If the Applicant would like to apply for scholarship funds towards a different AI course than listed on Page 1 of this Application, please list the name, cost and location of that course, and please include a statement with an explanation why you believe this course will be valuable to you and why you should receive funding.*
