


7/1/2023. The seminar was applicable to General and Residential Appraisers as well as users of Appraisal Services. Appraisal Standards Board Adopts New Edition of USPAP

New edition will be effective January 1, 2024

On May 5, the Appraisal Standards Board voted to adopt the Fifth Exposure Draft of proposed changes to the Uniform Standards of Professional Appraisal Practice (USPAP). The new edition will be available this fall and will become effective on January 1, 2024. Unlike previous editions, it will not have an end date.

All exposure drafts are developed by the Appraisal Standards Board and released for public comment. Successive exposure drafts are updated and released based on public comments on previous drafts.

REMINDER: The 2020-2021 USPAP is effective until December 31, 2023.

Appraisal Inst. Seeks Nominations for Annual Awards; Due July 31

The Appraisal Institute announced May 3 that it is accepting nominations for its J. Scott Robinson Lifetime Achievement, Outstanding Service Award, William S. Harps DEI Award and Women's Initiative SPOTLIGHT Award, four ways that AI recognizes some of its brightest and most deserving professionals.

Nominations for all four awards are due July 31. The awards will be announced at Al's Joint Region and Chapter Leadership Program meetings in October in Louisville, Kentucky.

The **J. Scott Robinson Lifetime Achievement** is presented to an Al Professional who best demonstrates high ethical standards; contributed to the Appraisal Institute at the chapter, regional, national and/or international level(s); provided service to his or her community; and contributed to the appraisal profession. A minimum of 20 years of service is recommended to be eligible for this award.

The **Outstanding Service Award** is presented to an Al Professional who has contributed ideas, service hours and dedication to ensure a specific program or effort is implemented at either the chapter, region, national and/or international level(s). This Al Professional must be instrumental to the success of the program or effort, which also must be far enough along to measure and provide proof of success. Additionally, the program or effort must be beneficial to chapters, regions, national, international, designated members, candidates, affiliates, practicing affiliates and/or the profession.

The William S. Harps DEI Award is an annual honor that was established this year to recognize an Al Professional who exemplifies the value of diversity, equity & inclusion within the valuation profession and has contributed to making the profession reflective of all the communities we serve. William S. Harps, MAI, was the first African American to earn the MAI designation (1960), a past president of American Institute of Real Estate Appraisers (1981) & a leader in breaking racial barriers in the appraisal profession.

The Women's Initiative SPOTLIGHT

Award recognizes an AI Professional who has made an important contribution to fostering the growth of women in the valuation profession. All AI professionals are eligible for this award.

PAREA: Practical Applications of Real Estate Appraisal



AI PAREA provides an alternative to the traditional supervisor and trainee model for experience for licensed residential and certified residential appraisers. It is an online program covering appraisal theory and methodology, in real-world simulations, with mentoring from nationally recognized appraisers. The content and activities in the AI PAREA program recreate the practical experience needed to gain a credential. Exercises, simulations, case studies, and applications are designed to enhance the AI PAREA program participant's existing appraisal knowledge. AI PAREA participants will develop at least three USPAPcompliant appraisal reports at the culmination of the AI PAREA program.

The Appraisal Foundation's Board of Trustees awarded the Pathway to Success Grant to the Appraisal Institute to assist with the development of the PAREA program. The Pathway to Success Conditional Grant is designed to open up the appraisal profession to a new generation of appraisers and stipulates that participant priority be given to veterans, minorities and those in designated rural areas. Al was awarded the full grant amount of \$500,000 to build its AI PAREA program in collaboration with its partners. Al committed more than \$2 million toward AI PAREA.

"The AQB's approval of AI PAREA for the licensed residential path is a significant milestone for our organization and the entire valuation profession," said Appraisal Institute President Craig Steinley, MAI, SRA, AI-GRS, AI-RRS. "This program will create many opportunities for aspiring appraisers who might not currently have a pathway into the profession."

Setting the Stage for Inputs: An In-Depth Look at an Inferred Markey Study

Appraisal reports convey opinions and conclusions that are to be based on credible market support. However, the reality is that this does not always occur. USPAP requires the appraisal to have market support, sound reasoning and logic for adjustments in a comparison analysis, all components in a cost analysis and the multiple aspects of an income analysis. This program will address the need for meaningful market analysis for properties that commonly transact and are located in relatively stable markets, using industry approved and peer tested techniques within the Six Step process. We will focus on how this can be accomplished in an inferred market study. Market analysis precedes and is the underpinning of the highest and best use analysis and conclusion. Many valuation reports convey opinions but often lack the underlying data and analysis to support the opinions and conclusions expressed in the report. Risk and Equity's Role

The program reviews the underlying risk factors that impact all real estate & the role of equity when acquiring and owning real property. Appraisal assignments generally seek to value the whole property as of an effective date and practitioners use the methods and techniques taught academically & gained while on-the-job. We will review factors that contribute to many factors including but not limited to overall & yield rates. It views investments from both the lender & equity investors positions. While the

various types of risk will be discussed, tools used by lenders will also be reviewed. Salient issues such as loan-to-value ratios, breakeven analysis, sensitivity need to be addressed when valuing income producing property. While most of the program will be relevant for the general practitioner, many risk issues are confronted by residentially valuers.


