On August 24, the chapter hosted a Zoom seminar AVOIDING BIAS: Building a Better Bias Defense. This 4



hour event was instructed by Frank Gregorie (shown) and Nicholas Pilz, MAI, SRA, AI-RRS. The seminar's intent was to meet the criteria set forth in

the Virginia CE requirement in HB284 (fair housing and appraisal bias.) This is effective with everyone renewing a Virginia real estate appraisal license as of 7/1/2023._ The seminar was applicable to General and Residential Appraisers as well as users of Appraisal Services. This offering reviewed suggestions available to all Virginia appraisers that can be



implemented in one's current work to help minimize or alleviate such allegations bv reviewing government requirements prohibiting discrimination in the valuation profession. The

Michael Mignogna Elected 2024 AI VP

Michael J. Acquaro-Mignogna, MAI, SRA, AI-GRS, was elected 2024 Appraisal Institute vice president by its Board of Directors during the Board's Aug. 10-11 meeting in Schaumburg, Illinois.

Mignogna's one-year term as vice president will begin Jan. 1, when he'll also serve for one year as chair of the Finance Committee. He'll serve as president-elect in 2025, president in 2026 and immediate past president in 2027.

He co-founded Mid-Atlantic Valuation Group in 2006 and is co-owner of the company with Gary E. Heiland II, MAI, AI-GRS.

Mignogna served as the 2013 president of the Philadelphia Metropolitan Chapter of the Appraisal Institute, following previous positions as vice president, treasurer and secretary, and three years on the chapter's board of directors. He has also served on and chaired Review & Counseling and Experience Review committees in addition to volunteering as a national experience screener and twice participating in the Appraisal Institute's Leadership Development and Advisory Council conference (LDAC). He served as one of the founding members of the steering committee for the Coalition of Pennsylvania Real Estate Appraisers and has served as the organization's treasurer since its inception in 2012. The coalition was formed by the Appraisal Institute's Pennsylvania chapters and other interested appraisal professionals to monitor and weigh in on relevant legislative actions at the state level that affect the valuation community and the public.

In 2016, Mignogna received the Felice A. Rocca Jr. Award and in 2017 the Harrison-Winder Award, both

presented by Al's Philadelphia Metropolitan Chapter. The Rocca award was created to honor a distinguished chapter member with "a high sense of ethical behavior on a personal and professional level" and is presented to recipients "who exhibit these qualities." The Harrison-Winder Memorial Award is presented in memory of two long-time appraisers "for all their efforts in advancing the appraisal profession."

After serving two years as the Metro Philadelphia Chapter's representative to Region VI, Mignogna was elected by the region to serve as its 2016 third director, moving on to the national Board of Directors from 2017 through 2020 as vice chair then chair of Region VI. While on the Board, he was elected to the Professional Liability Insurance Program Committee, serving as its chair in 2019 and 2020. He was twice elected to two-year terms on the Audit Committee (2020-2023), serving as vice chair in 2021, chair in 2022 and vice chair again in 2023.

Al Board of Directors Seeks Membership Input on Proposed Regulation Changes

The Appraisal Institute Board of Directors voted during its Aug. 10-11 meeting to direct notice of proposed amendments to Regulation No. 2 regarding Admission to Residential Candidacy and SRA Membership for comment. The Board also voted to:

- Adopt proposed amendments to Bylaws and Regulation No. 4 regarding Recognition for Life Designated Membership and to adopt a Designated Member Policy Manual.
- Adopt proposed amendments to Regulation Nos. 2 and 3 regarding the Residential and Residential Review Experience Requirement.
- Adopt proposed amendments to Regulation No. 10 regarding Designated Member Continuing Education Cycles.
- Amend Chapter Funding Policy for Candidates for Designation and Practicing Affiliates.
- Approve the unification of the Chicago Chapter and the Northern Illinois Chapter.
- Adopt the proposed 2024 budget.
- Amend policy pertaining to maximum annual income for Designated Members with Practicing Semi-Retired status.

NEWS FROM FANNIE MAE

Effective Date for Main Living Area Photographs in On March 1, 2023, we made a number of updates to the Selling Guide, including introducing value acceptance + property data, hybrid appraisals, and completion alternatives. In this update, we also provided additional details for appraisal report interior photograph requirements for the main living areas of the property to include the living room, family room, dining room, all bedrooms, and all finished and unfinished areas of the basement. Appraisers may already be complying with these photograph requirements for the main living areas, and we encourage compliance immediately if not already doing so. However, we will require the full complement of main living area photographs for appraisals in loan applications dated on or after Sept. 1, 2023. See Selling Guide, <u>B4-1.2-01</u>, Appraisal Report Forms and Exhibits for the complete list of appraisal exhibits and photograph requirements.

PAREA: Practical Applications of Real Estate Appraisal

The Al PAREA pilot program for licensed residential was launched in July. By design, the pilot program is starting small, with 15 individuals who have completed their QE and reside in a state which has fully accepted PAREA in lieu of the traditional supervisor/trainee model. While the initial number of individuals in the pilot program is small, the potential impact is huge. The organization is still on-track to launch Al PAREA broadly & open registration in September, so stay tuned for further details.
